Pharmaceutical Testing Division

The pharmaceutical industry uses a very large variety of raw materials and hundreds of ingredients can go into the manufacturing of a single product. It is often difficult for a pharmaceutical manufacturer to have in-house testing facilities and capabilities for all the ingredients and products. A great deal of effort is spent at establishing specifications for the active ingredient and that of the finished product during a product's development cycle. Specifications for the raw materials must also be established. Failing to do can result in manufacturing delays and production lot failures. Laboratory testing of pharmaceutical products ensure a consistent level of quality, as well as safety.

Food Testing Division

To identify contaminants or hazardous components if any in raw material or contamination after a product is produced and before it is placed on the market. Laboratory testing is important for the research and development of new food products, including, for example, the choice of ingredients or components, the design of food processing, shelf-life studies. This is the kind of information food scientists need when developing new products. Another benefit of food testing is compliance with regulations for both the import and export of food products to different countries.

We provide following food testing facility:

Chemical and analytical testing, Nutritional labeling, Stimulant foods, Meat and meat products, Fruits and Vegetables product, milk and dairy products, bakery products, Food grains, pulses, cereals, seeds and related products, Honey, Fat, Spices, Spice Oils, Oleoresins, Heavy metals and Residue in foods.

Water Testing Division

Whether your drinking water comes from a public water supply (city water) or private well and/or spring, each drinking water source may be at risk for contamination and you need to know what are those contaminants are and how you might protect your family from the risks associated with contamination. Water apart from being used for consumption, also plays a vital role in many manufacturing units, industries and establishments. The quality of water used will definitely affect the grade of the final product, and hence testing for the quality of this essential unit becomes imperative.
